PURPOSE OF COMPETITION

To encourage and recognise companies that have generated substantial and sustained increases in export activity.

JUDGING CRITERIA

In determining the winner, the judges will take the following factors into account:

- The level of exports and their growth in relation to the size and turnover of the Company.
- The planning and strategy involved in developing export markets – e.g. trade fairs, visits
- The barriers that have had to be overcome e.g. languages.
- The degree to which products/services are new or adapted to market and markets non-traditional.
- Sustained effort will be considered to be over a period of at least three years

ELIGIBILITY

The competition is open to British based companies exporting products with significant UK content or added value.
